requirements. Brokerage account showed a loss of \$536 in December 2021, now showing a loss of \$1256 as of March 2022. W. Andersen and J. Staats will meet to continue work on the investment charter.

- c. Administrator's Report - M. Ballance: EAGLE charter received Gold again in the annual Best of the Mid-Willamete Valley again. Office is closing officially on June 29th. Office will not be open in July. Financial management will be back in Micro next year (businesses, shopping, etc.). Micro at a National level is behind where we would like for teaching finances to Elementary school. Staff is looking into other options to help enhance the financial education of the students. Micro Society is more focused on Middle School, than Elementary School. SBAC numbers were lower this year. Part of this was to be expected coming out of the pandemic and learning test taking again. A portion of this is also due to the number of Special Needs students we have, but our Special Needs students are doing better than the state. W. Andersen asked if EAGLE has a program for gifted students. Students who need extra challenges to stay interested and focus are treated similar to Special Needs, case-by-case to determine what the student(s) need to continue challenging them. Multi-grade Micro will be coming back and this will also give gifted students a chance to show their abilities to other grade levels. There will be after school clubs coming back as well. Back-to-School BBQ August 30th 5-7pm

Parent Club: No Parent Club report. Parent Club approved new bylaws and elected all new officers. \$9,075 in their budget as of June meeting. Ashley Klein (President), Ester Furtado (Vice President), Krystal Kuester (Secretary), still uncertain on treasurer (Zoom cutoff during the voting).

We have enough technology, desks, and space to comfortably accommodate increasing class size in select grades. Dr. Ballance is more confident in the Math Ready stats than the Reading Ready stats. Outdoor School - We are not assured of a grant for 5th grade Outdoor School. Dr. Ballance is waiting to see who we hire as the 5th grade replacement since Mrs. Mars has left. J. Staats asked if there were any additional compensation for custodial staff as a thank you for their extra work since the pandemic. Dr. Ballance increased the funding last year for custodial services to reflect increases in duties. There should be funds to increase again this year to show appreciation for her work. J.
